U.S. Rates and Rules Report

Foreward

Tax changes are always a hot topic amidst times of political change, and 2025 is no exception. After a volatile 2024 campaign, where tariffs and economic policy led many news cycles, Americans are more concerned than ever about how taxes impact their wallets.

But as those of us in the world of tax understand, the overall taxable ecosystem goes far beyond political rhetoric. Americans are, on average, facing higher tax rates and adopting more new taxes each year. However, these payments are increasingly directed to local entities—counties, cities, and districts—rather than to state or federal governments.

The Vertex 2024 End-of-Year Sales Tax Rates and Rules Report spells out clearly how much change is taking place under the surface. In 2024, none of the 50 U.S. states changed its sales tax rate. That follows a 10-year period where states made just 15 changes – seven rate increases and eight cuts.

Meanwhile, counties, cities and districts have been busy. In 2024 they changed rates or added new taxes 588 times – down from a near record in 2023, but roughly at the average mark over the past decade. Cities changed 251 sales tax rates in 2024 – second most in a decade. The number of county rate changes and new taxes has slowed in recent years, following a period of record levels of change in the 2010s.

Tax rate increases in 2024 outnumbered decreases 5:1 in counties and an astounding 8:1 in cities. While districts went against the grain, cutting twice as many rates as they raised, the number of new district taxes reached its third highest level since 2017.

What's driving all the change? Economic factors continue to put pressure on local entities and force them to find new ways to raise revenue. Inflation is back under 3%, down from 9% in mid-2022, but costs remain stubbornly high. After cutting services for years, municipalities have little room to cut. High interest rates are raising the cost of issuing bonds. And with the last of the pandemic-related U.S. Federal government funds paid out in 2024, communities turn to taxation as a last resort.

At the end of the day, life is getting more expensive, and taxpayers are paying the price. As tax rates change and the tax landscape itself grows more complicated, businesses are paying a price, too. They need help dealing with the increasing intricacies of tax compliance.

Additional Information

- Puerto Rico currently has the highest state sales tax rate at 10.500%. Indiana, Mississippi, Rhode Island, and Tennessee have the second-highest state sales tax rates at 7.000%.
- Kodiak, Alaska, Wrangell, Alaska, and Winter Park, Colorado have the highest city sales tax rate at 7.000%. Hoonah, Alaska, Klawock, Alaska, and Selawik, Alaska have the second-highest rate of 6.500%.
- Sterlington, Ouachita Parish with the Sterlington Economic Development District No. 1 in Louisiana has the highest combined sales tax rate of 12.950%.
- Redwood Valley, Mendocino County with the Mendocino County Transaction and Use Districts and Coyote Valley Band of Pomo Indians Reservation in California has the highest combined sales tax rate of 16.75%.
- Since 2014, there have been 2329 new sales and use taxes, an average 233 per year.
- Since 2014, there have been 3779 sales and use tax changes, an average of 378 per year.
- The combined number of new and changed sales and use tax rates since 2014 is 6108, an average of 610 per year.
